
President's REPORT

- 5. Strive for operational excellence





The organization's financial resources have been managed in a sustainable manner, and we continue to remain in a solid financial position, with enough in our general fund and reserve to meet future demands and obligations.

The annual audit for the year ended January 31, 2025, and was conducted by RDS Chartered Professional Accountant Prof. Corp. The audited financial statements accompany this report.

I am pleased to highlight that 2024 was filled with continued growth and success for SLA. SLA began the year with an operating fund increase of \$18,000 bringing Sask Lotteries annual operating commitment to \$201,000 per year, as part of the new 3-year funding model. SLA is grateful to Sask Lotteries for their continued support enabling the organization to advance Saskatchewan's library and information community, and through libraries, the privilege of serving an audience varied in age, from all socioeconomic backgrounds and diverse cultures. My gratitude is extended also to Sask Culture Consultant, Paul Gingras for his support and service to the organization.

SLA remains committed to ensuring member value by providing diverse, informative, and relevant opportunities for engagement, networking, and professional development. In 2024, a new award category and two new programs were introduced; The Early

Career Librarian Award of Merit, The Peer-to-Peer Mentorship and Forums, are exciting new additions to the already established categories of Programming and SLA Career & Student Awards, which bring complement to the Continuing Education Grants, Webinars, Provincial Libraries Conference, and the multitude of library program grant funding opportunities. In addition to the above, in 2024 the Board of Directors also approved developing an Indigenous Reads Program. The program will showcase Indigenous authors and their stories across Saskatchewan, Canada, and beyond.

SLA continues to focus on maintaining and creating new community partnerships to benefit the provincial library community and residents of Saskatchewan. In 2024, SLA partnered with the First Nations University of Canada (FNUniv) and the Saskatchewan Ministry of Government Relations, Indigenous and Northern Relations,


First Nation and Métis Relations Unit to reintroduce The Northern Tour Program and launch a new program -The National Indigenous Peoples Day Grant Program. The programs allow the Saskatchewan library sector to celebrate the many important contributions Indigenous Peoples have made and continue to make in our province and for residents, the opportunity to learn more about their culture, traditions, art, and spiritual teachings. The programs are a measure of the organization's commitment to respond to the 94 Calls to Action - to walk a path of reconciliation, through education, and with honour and respect.

The Saskatchewan Library Association continues to support the mandates of several external cultural and educational organizations in Saskatchewan. SLA is pleased to report that in 2024, the Association was invited to serve as a member of the search committee for the Dean of the University Library at the University of Saskatchewan. SLA is further grateful to the many representatives who have highlighted these organizations within this publication.

Recognition for the continued advancement of the organization can be attributed to the many hard-working volunteers who dedicate themselves to the important work of several committees. Their impactful work can be credited to the success in all areas of the organization, but specifically in 2024, their collective contributions

saw positive results in the membership area, with an increase in both individual and institutional memberships (8% for individual and 6% for institutional). I wish to extend much gratitude to the incredible team of volunteers - thank you for your impactful work!

In closing, I wish to extend my thanks to our members, your support enables us to continue serving Saskatchewan's vibrant library community. My gratitude, also to President, James Howard, and the SLA Board for their leadership and support this past year. The success of our organization is closely connected to the effort, experience, and collaborative work of our board. My thankfulness is also extended to my colleagues Milena Džordeski and Yasmin Dar for their dedication and valued contributions to our work of supporting and advancing the Library Sector in Saskatchewan. Following last year's modest decline in membership levels, the Communications and Engagement Committee set to work on developing new ways to actively





Thank you to outgoing members Danielle Raymond (Saskatchewan Polytechnic), Riane Lapaire (National Network for Equitable Library Service), and Lynn Penner (SLA) for your time and effort with the committee.

Early 2024 saw the release of the SLA Statement on Material and Program Challenges. This statement is supplemental to the 2023 statements regarding intellectual freedom and open access and was created in response to the growing climate of

materials challenges in Canada. Freedom to Read Week (February 18-24), hosted a Bail Out the Banned Book contest on social media. Participants who liked a post featuring a banned or challenged book by a Canadian author were entered to win a copy.

Our most prominent focus for 2024 was advocacy leading up to and during the Saskatchewan provincial election. We completed work on the SLA Advocacy Toolkit, which we released at the 2024 SLA Conference. This toolkit was intended for both staff and the general public to be able to ask candidates questions, express the benefits of libraries, and learn a bit more about the provincial budget cycle. Following the election, MLAs received a congratulatory

letter, highlighting the value libraries play in building and maintaining communities, and our continued desire to further the development of library service by connecting, inspiring, and advancing the library and information management community that reflects all Saskatchewan people. Our final initiative in progress for 2024 was investigating best practices to solicit SLA member input regarding the Committee's plans and activities. We are currently exploring these possibilities through the SLA member website.

The Advocacy Committee continues to engage in exciting initiatives that we hope will further the advocacy work of libraries across the province. Thank you again to all committee members for your input and hard work.

ADVOCACY COMMITTEE



PRISON LIBRARY SUB-COMMITTEE



The Prison Library Sub-Committee (PLSC) had another productive year, providing quality reading materials to incarcerated individuals at Regina Correctional Centre, White Birch Remand Centre, and Paul Dojack Youth Centre. We gratefully received book donations from many community members in Saskatoon and Regina, as well as a few generous financial contributions. Alongside used materials, we purchased several new items to fill specific requests from students at Paul Dojack Youth Centre and a large batch of dictionaries for Regina Correctional Centre. In terms of advocacy initiatives,

the PLSC began Books Behind Bars - a quarterly book recommendation on social media that highlights issues relating to criminal justice and incarceration. Committee members are also presenting an information session and hosting a vendor booth at the 2025 SLA Annual Conference.

Thanks to an unexpected and exciting supplement to our budget, we were able to purchase the infrastructure and supplies needed to create a physical library at Regina Correctional Centre. This will drastically improve inmates' access to books and reading options

throughout the facility. The committee expects the coming months to be focused on helping establish that space and develop systems for its operation.

We look forward to continuing to strengthen and expand access to library services within the carceral system in Saskatchewan.

CONTINUING EDUCATION COMMITTEE

The mandate of the Continuing Education Committee is as follows:

- Develops and promotes continuing education opportunities for members.
- Promotes and adjudicates applications for the Continuing Education (CE) Grants; considers and recommends new continuing education initiatives to the Board.
- Ensures policy and guidelines are current and relevant.
- A sub-committee adjudicates award applications.

Three grant applications were received and adjudicated in 2024. The Committee has boosted efforts to raise awareness of the CE grants and is ready to review the Spring 2025 applications after the February 15 deadline passes.

The Committee has also offered, or is planning to offer, the following webinars for the 2024-2025 year:

- "Professional Ethics & Political Realities: Responding to Intellectual Freedom Challenges in Public Libraries," FTRW webinar presented by Sharon Day and Michael Dudley, representatives from the CLFA-FCAB Intellectual Freedom Committee.
- "Accessibly: Strategies for Creating Accessible Conference Presentations," presented by Riane LaPaire from the National Network for Equitable Library Service (NNELS).
- "Unstuck in the Middle: Lessons for Leading Up, Down, and Across in a Library," panel discussion led by Mark Black, Branch Manager at Regina Public Library's Central Branch.

- "Developing Inclusive Mindsets & Eliminating Bias," presented by Nura Mehammed and Zane Arnott from the Saskatchewan Intercultural Association.
- "Othering, Discrimination & Racism," presented by Lara Paul from the Saskatchewan Intercultural Association.
- "AI, Bias and Libraries: Expanded Edition," presented by Veronica Ramshaw from the University of Regina Library.
- "Modernizing Library Reading Programs for Adults," presented by Devon Stolz, from the University of Toronto (and previously at Regina Public Library.

At the time of writing, we are also pursuing leads for additional sessions. The Committee expresses its gratitude to CE session presenters for sharing their time and expertise for the benefit of SLA members. We would also like to thank Lynn Penner, Milena Džordeski, Yasmin Dar, and Tina Kleisinger in the SLA office for their expert support of our work.

PROGRAMMING

Thank you to all the Program Committee members: Tawn Marshall of Lakeland Regional Library, James Hope Howard, SLA's Board President & PNLS Director, Morgan Kelly of Southeast Library Region, Sean Stares of PNLS (until April 2024) and Kate Wagner of Legislative Library. We welcomed a new member on this team in April 2024—Emily Wong of PNLS, who provided an exciting new member input to our monthly discussions.

Here are the highlights of the activities that took place in 2024:

Family Literacy Day is an event marked every year on January 27 in libraries and literacy organizations across the country to raise awareness about the importance of reading and engaging in literacy activities as a family. The 2024 Family Literacy Day theme was "Let's have a family party!"

SLA awarded seven libraries with

grants to help them provide suitable programming for families in their communities. Their programs took place in libraries from Eastend to Loon Lake, including activities such as Indigenous story reading, interactive story sack kits, family popcorn writing, a stuffy sleepover, mad hatter tea party, and a family party around the world!

The inaugural **2024 National Indigenous Peoples Day Grant** was formed with the input of Wendy Sinclair, RPL's Indigenous Services Advisor, and Deborah Pelletier, SLA's Board Member at Large. The nine grants were given to libraries across the province to celebrate the important contributions of Indigenous peoples and the national holiday on June 21. SLA gratefully acknowledges funding support for these grants by the Saskatchewan Ministry of Government Relations, Indigenous and Northern Relations, First Nation and Métis Relations Unit.

Summer Performer Tour

SLA again provided grants of up to \$300 to support in-person summer programming across the province. In 2024, grants were distributed to fifteen libraries to provide their communities with diverse programming. Part of the programming included a reading challenge, a community garden, Lab Rat Biology, "A Taste of the World" food event. Other libraries hosted community partners such as the Adventure Wranglers Reptile Show, Saskatchewan Science Centre's Go! Science Travelling Tour, and "Mr. Fric" Musical Tour with Fric Petkau. Libraries immersed their audiences in art and culture, providing them the

opportunity to learn about famous painters, create pendulum art and clay faces, and fine art.
Once again, SaskTel's generous sponsorship supported the funding of the summer grants.

A Northern Tour Program

In 2024, SLA reintroduced the tour to Saskatchewan's Northern with the generous sponsorship of the First Nations University of Canada and the Saskatchewan Ministry of Government Relations, Indigenous and Northern Relations, First Nation and Métis Relations Unit.

The Tour visited nine Saskatchewan locations including: La Ronge, Montreal Lake, Stanley Mission, Pinehouse, Île-à-la-Crosse, Beauval, La Loche, Buffalo Narrows, and Pelican Narrows and hosted 205 participants during the week of September 16-20, 2024.

The tour featured Harmony presenting

her painting, Kookum Magic, inspired by her father Harold Johnson's short story, and guiding participants through storytelling traditions and symbolism.

Each session included a hands-on creative activity where participants used symbolic materials to create mnemonic story sticks, representing personal or cultural stories important to them. The workshops encouraged youth and adults to explore the power of storytelling through traditional and personal narratives. The sessions concluded with a sharing circle, where participants shared their creations and the stories they represented.

Culture Days is an annual event that raises the awareness, accessibility, participation, and engagement of Canadians in the arts and cultural life of their communities from mid-September to mid-October.

In 2024, SLA provided eight grants of \$200 to libraries from different parts

of our vast province to provide their communities with activities such as creating a positive message stone path, beading poppies, wool needle felting sculpture, as well as learning opportunities such as a Chinese calligraphy class, an international potluck supper, and a multicultural festival. The hosted events allowed residents the experience of new creative and cultural activities.

The limited number of eligible grants did not deter Saskatchewan's vibrant library community from hosting events - SLA is proud to share that 44 library events were held across the province during Culture Days!


2024 Saskatchewan Library Week took place from October 13–19, with the theme - "Grow with Your Library."

SLA distributed seventeen grants of up to \$250 to libraries across the province to fund a variety of engaging activities,


some of which included: an applegrowing project, a pumpkin pie social, and an escape room. Other fun activities included: "Librarian for a Day", and "Patron Appreciation Day." Once again, the diversity of the activities that took place during the third week of October showcased the important and versatile roles libraries have in the lives of our communities.

Book Spine Poetry Contest

Book spine poetry comes to life when a pile of books is arranged in such a way that a title from each book spine represents a line of a poem.

Book Spine Poetry Contest is one of SLA's most popular programs, and it draws participants in four different age categories, from all over the province. For the first time last year, we welcomed 13 entries in French!

In 2024, we received 274 entries in total, of those, 69 were submitted by adults, 69 by teens, 125 by children ages 9-11, and 11 by children ages 5-8. The poems were adjudicated and three winners in each category received McNally Robinson Booksellers' gift cards as prizes; two of the winning poems were in French.



Regional Park Pass Lending Program

The Regional Park Pass Lending Program is a partnership program with the Saskatchewan Parks and Recreation Association (SPRA), Saskatchewan Regional Parks Association (SRPA), and the Saskatchewan Library Association (SLA).

In 2024, the program ran successfully for the third year.

Throughout the summer of 2024, (May 17 to September 15), 856 regional park passes were made available on loan to Saskatchewan library card holders. The program aimed to enhance knowledge of and visitation to Saskatchewan's nearly 100 regional parks and 307 library branches while also providing equitable access to Saskatchewan's beautiful nature.









One Book, One Province, Saskatchewan (OBOP) aims to increase literacy and to create a reading culture by providing opportunities for residents to become more socially engaged in their community through a shared story. OBOP encourages Saskatchewan's social, economic, and cultural development while supporting libraries and collaboration.

This year's selection was Jennifer S. Wallace's Miss G and Me, an awardwinning book that shares a daughter's insights into her Jamaican mother's immigration story and familial relationships, weaving together poems, journal entries, anecdotes, and personal essays, and inviting readers to experience Jamaican, English and prairie Canadian voices, cultures, landscapes, and mindsets. A French immersion teacher, judo sensei, writer, artist, and author, Jennifer focused on "partnering with communityminded organizations interested in celebrating women, newcomers, diversity, nourishment, the health system, education and familial ties. This bursary is open to any person of Canadian Indigenous ancestry (First Nations, Métis, or Inuit) who is enrolled in or accepted to an American Library Association (ALA) accredited graduate degree program in library and information science or equivalent.

In 2024, Colton Whelpton was chosen as the recipient of the Indigenous Student MLIS Education Bursary. Colton is a member of the Tl'etinqox Government (Anaham) band, was born in Regina, Saskatchewan. Coltin now lives on the traditional and unceded lands of the Musqueam people (Vancouver, BC). He serves as the Library Services Manager at the John Richard Allison Library at Regent College, supporting the diverse research needs of this graduate institution. Colton holds a MATS (2021) from Regent College and is currently pursuing an MLIS online through the University of Alberta.



MARY DONALDSON AWARD OF MERIT

The Mary Donaldson Award of Merit was established in 1977 to recognize library technicians and the essential services they provide in Saskatchewan libraries. Prairie Representative - Canadian Federation of Library Associations/Fédération canadienne des associations de bibliothèques (CFLA-FCAB) Board of Directors

Since joining the Canadian Federation of Library Associations (CFLA) as the Prairie Representative in November 2024, I have had the opportunity to engage in national discussions shaping the future of libraries in Canada. The CFLA plays a crucial role in advancing library excellence, championing library values, and influencing public policy at both national and international levels.

Early in my tenure, I identified an opportunity to contribute my expertise in library marketing and communications. Recognizing concerns about momentum loss following the transition from the Canadian Library Association, I joined a consultation meeting focused on rebranding and refreshing the CFLA's website and overall brand identity. This effort aims to reestablish CFLA as a recognizable leader in Canadian library advocacy and policy.

During my short time on the board, I participated in decisions, including the approval of the Joint Position Statement on the Importance of Health Libraries in Canada. This statement highlights the essential role of health libraries in supporting professional development, medical training, and patient care decision-making.

Additionally, the board approved a letter to the Access to Knowledge Coalition (A2K), emphasizing concerns regarding WIPO's role in public lending rights and the limitations and exceptions concerning broadcasting rights. Key signatories, including CARL and IFLA, have also endorsed this letter.

We also supported an update to the Intellectual Freedom Committee Toolkit, ensuring its continued relevance in addressing pressing challenges facing libraries across Canada.

I look forward to further contributing to CFLA's mission in the coming year as the Prairie Representative for SLA.



CFLA-FCAB Copyright Committee

I was appointed to the Copyright Committee in November 2024, replacing Christina Winter who was recognized for her long and valuable service to the committee. The Copyright Committee is active, meeting monthly to review the progress of the projects. Most projects are initiated from within the committee.

Since joining, I have initiated a review of contract over-ride. CFLA has a statement on contract override that was issued a few years ago. The review will look at new policy statements globally, as well as more recent court decisions to determine if the statement should be updated. I have also joined the Controlled Digital Lending review committee; their review is based on the Internet Archive / Hachette United States lawsuit, which has continued to provide advice over the past two years.

The Copyright Committee is formed

based on representation from different library sectors in Canada. The appointment of Carol Shepstone to the Saskatoon Public Library has resulted in her appointment as the representative to the committee from the Canadian Urban Libraries Council (CULC).

I am pleased to advise that the Committee is currently working on several other projects including: an e-book collaboration in partnership with industry representatives, input into the federal consultation on artificial intelligence, and a guide for libraries on accessible content and its production and distribution. The committee has a strong history of making significant contributions to addressing policy on copyright in Canada and ensuring the library sector is well represented. I would be interested in considering any copyright concerns or issues identified by the SLA that may require consideration by the committee.

I am grateful to represent SLA on the CFLA Copyright Committee.

The Committee on Indigenous Matters (Le Comité des affaires autochthones) exists to:

- explore issues and identify workrelated concerns as well as sound practices and identify current work and sound practices related to the service offerings of libraries, archives and cultural memory institutions with and for Indigenous (First Nations, Metis and Inuit) peoples on behalf of CFLA-FCAB
- promote initiatives in all types of libraries that advance and implement meaningful reconciliation as addressed by the Truth and Reconciliation Commission report and in the Calls to Action
- to promote collaboration on these issues across all Canadian memory institutions including,

libraries, archives, museums, and educational and cultural organizations, and

 to monitor ongoing progress in these areas.

In 2024/25 The Indigenous Matters Committee released a "Steps to Reconcili-Action Report".

Following the release of the Reconciliaction Report and its highlight on supporting Indigenous Librarians, IMC began a new project, a Community of Practice for Indigenous Information Professionals, and has since held two meetings. This pilot program will run for a year with a final report to the CFLA Board with recommendations and further actions.

CFLA-FCAB Board has proudly appointed the next Committee Chair, Bethany Peterkin. Bethany is a member of the Manitoba Métis Nation and was born and raised on Treaty One territory. She is currently acting as the Indigenous Teaching, Learning & initiatives Librarian at Capilano University.


Library Services for Saskatchewan Aboriginal Peoples Committee (LSSAP)

The focus of the LSSAP committee for 2024 was the 21st annual Storytelling Month project. Wapiti Regional Library hosted the 2024 launch, with the Humboldt Reid-Thompson Public Library and Humboldt & District Museum and Gallery hosting Knowledge Keeper Lyndon Linklater for presentations to school children and the public.

With the support of 125 volunteers, libraries hosted 103 storytelling sessions in over 61 locations, with over 10,000 participants. 52 Storytellers shared a variety of contemporary and traditional stories. The committee thanks all Storytellers, Elders, Knowledge Keepers, hosts and audience members who took part and made Saskatchewan Indigenous Storytelling Month 2024 a success.

Major initiatives in 2024-2025 included:

Indigenous Subject Headings

The Saskatchewan Indigenous Subject Headings Project has the aim of modernizing terms in library catalogues related to Indigenous Peoples in Saskatchewan. This project is a response to the Canadian Federation of Library Associations-Fédération canadienne des associations de bibliothèques call to action 5 that "libraries

should strive to decolonize access and classification". The Saskatchewan Indigenous Subject Headings are available online at https://mlb.libguides. com/SK_ISH.

Science Online

The Multitype Library Board approved funding for a new STEM (Science, Technology, Engineering and Math) resource, Science Online, for three years (August 01, 2023 - July 31, 2026). This resource is available to all partners in the Saskatchewan Electronic Resources Partnership (SERP) program.

The current chair of MLB is Abigail Durkee from Briercrest College and Seminary. The MLB Annual Report for the fiscal year 2023-24 was tabled in the Legislative Assembly on July 29, 2024. Saskatchewan Book Awards

The Saskatchewan Book Awards began operations in 1993 when the Saskatchewan Writers' Guild, Saskatchewan Publishers Group (now SaskBooks), and the Saskatchewan Library Association joined forces to establish a provincial writing and publishing awards program.

Since its inception, The Saskatchewan Book Awards has had a strong reputation across Canada's writing and publishing communities. It provides a supportive environment for Saskatchewan's authors and publishers, as well as a venue to showcase our province's literary talent.

The 31st Annual SBA Gala and Award Ceremony, held at the DoubleTree by Hilton Hotel and Conference Centre in Regina, SK on Friday, May 3, 2024, drew an intimate crowd of 190 guests including authors, publishers, sponsors and community supporters who attended the event and celebrated winners in 13 award categories. Of the 195 entries submitted to the Saskatchewan Book Awards 2024 Call for Submissions, 39 jurors from across Canada selected 35 books as finalists

that were announced at the SBA Shortlist Announcement held at the Regina Public Library on March 1, 2024. Regina Public Library's Indigenous Storyteller-in-Residence, Dickie Yuzicappi, announced finalists for shortlisted authors and publishers in 13 award categories.

The evening's video presentation was produced by Amplify Digital Corp., and Access Communications cable network aired the awards ceremony on three occasions, following the event. CBC announcer, Candace Holmstrom, and Darian Agecoutay, Indigenous Lecturer from First Nations University of Canada, contributed to the voiceover. Involving a Cree language speaker to correctly pronounce all the Indigenous titles provided honour and respect to the authors and their Indigenous book titles.

Tim Blackett was a double award winner for his book, *Grandview Drive*, won the First Book Award sponsored by the Ministry of Parks, Culture and Sport, Government of Saskatchewan, and the Fiction

Award sponsored by Saskatchewan Book Awards. Other double award winners included Saskatoon author, Maria Endicott, whose book, *The* **Observer**, won the City of Saskatoon Book Award and the Book of the Year Award. Of note were double award-winning Indigenous authors, James Brady McDonald, whose book, **Carrying It Forward: ESSAYS FROM** KISTAHPINÂNIHK, received two awards for Non-Fiction and Indigenous Peoples' Writing, and Solomon Ratt, whose book, The Way I Remember, published by University of Regina Press won the City of Regina Award and the Publishing Award. Gabriel Dumont Institute Press was also a double award recipient, winning the Publishing in Education Award and the Indigenous Peoples' Publishing Award for Gregory Scofield's book. Saskatchewan Polytechnic Library & Information Technology Advisory Group

I am pleased to report that 27 students graduated from the program in 2024 and that future students will soon enter a new facility as Saskatoon's new Sask Polytechnic campus is underway. A master plan for the other three campuses has also begun.

Other school initiatives include building a 5-year comprehensive strategic plan, increasing domestic and Indigenous enrollment, increasing industry connections, and employee engagement initiatives.

A five-year comprehensive curriculum revision was completed last spring and implemented in the fall. The team is also working with the Continuing Education Until to develop new micro-credentials in the areas of Al. The future continues to shine bright for Sask Polytech in many aspects from continued collaborations, the use of Al, new campus buildings, and innovative educational opportunities for students.



University of Regina Senate

Key work:

The University of Regina Senate's general area is the academic welfare of the institution which has a variety of duties and powers. Most of the broader issues of academic policy within the University are reserved for its approval. In another role, it acts as an ultimate court in academic affairs.

The following are highlights from the meetings:

Key messages:

- The record enrolment that the University saw in the Fall of 2023 carried over to the Winter 2024 term, up 8.9% compared to Winter 2023. This upward trend continued into the Fall 2024 increasing 3.1% from the Fall 2023 term. With at total enrolment of 17,288 students, the University has a new all-time record.
- The University officially kicked off their 50th Anniversary on July 1, 2024 50 years to the day that they became an autonomous degreegranting institution. Several events were hosted throughout the year

- including public lectures, a concert in honour of Dr. Lloyd Barber and outdoor 'Decades Movie Nights'.
- Two athletes from the University of Regina competed in the 2024 Paris Summer Olympics. Swim team member Ovesh Purahoo of the Faculty of Kinesiology and Health Studies represented his home country of Mauritius in 100-metre freestyle, and Kenzie Priddell of the Faculty of Education competed for Canada in artistic swimming.

University Library:

- In May 2024, the Dr. John Archer Library launched a new interlibrary loan (ILL) system called Rapido, designed to enhance patron access to resources from libraries worldwide. This new system has made it easier than ever to get the materials, no matter where they are housed.
- Also in May, renovations on the main floor of the library began. In August the brand-new service desk for Information Services staff was opened after being temporarily relocated to the main Help Desk. The service desk staff can assist with computer and technology questions, printing set-up, U of R username and log-in troubleshooting, and other related issues.
- On June 25, 2024, the library celebrated National Indigenous History Month and National Indigenous Peoples Day. Elder Betty McKenna, from Sapotawayak Reserve, Treaty 4 Territory in Manitoba and


Dr. Fidji Gendron, Associate Dean (Academic) and Professor of Biology at First Nations University of Canada, presented on the importance of flora and land-based knowledge from an Indigenous worldview. The event was free and open to the public.

The University of Regina Author Recognition Program celebrated its 10th anniversary in November 2024. The Dr. John Archer Library and Archives invited the campus community to join their celebration of 2023-24 University authors and creators. The program showcased not only printed text works but a variety of creative or scholarly projects published in various media such as artworks, websites and app development.

Just a reminder, members of the community, including faculty, staff, and students, can now pick up and return their public library materials at the new pickup station in the Archer Library. This opens up access to materials from library locations across the province, which can be delivered to the Archer Library pickup location within just a couple days.

April 20, 2024, Meeting Review

U of S President Stoicheff shared the university's successes including receiving an increase in funding to develop new health science programming. He also celebrated that among the 97 universities in Canada eligible for the nation's 11 Rhodes Scholarships, the University of Saskatchewan students received two

this year. From various standing reports presented at the meeting, the Senate also learned that undergraduate and graduate associations are focused on supporting student mental health, service accessibility, and creating a sense of community and welcome.

October 26, 2024, Meeting Review

U of S President Stoicheff shared that honorary degree recipients for 2024 included philanthropists and business leaders Gordon and Jill Rawlinson, Man-Booker Prize-winning author Yann Martel, and Nobel Prize-winning scientist Dr. Emmanuelle Charpentier, PhD. The report also celebrated USask receiving its highest-ever performance in the QS World University Rankings (340th), and a place in the top quartile of ranked universities in the world for the second year in a row.

Information about the selection of the next University President was shared in a report from the Board of Governors. Dr. Stoicheff will complete his term at the end of 2025. The search for a new President will include both community and campus engagement, and more information can be found at https://governance.usask.ca/presidential-search/index.php. The Senate will also be selecting a new Chancellor at the spring meeting in 2025.

Senate Education Sessions

Two education sessions were presented to the University Senate at the spring meeting.

The Chief Sustainability Officer presented an overview of USask's progress on its Sustainability Strategy. The Sustainability Strategy includes a vision of not only physical environment, but also education, wellness, equity, and justice. It was noted that USask is creating an inventory of new sustainability-related courses as well as maintaining the existing courses that share this focus. Major challenges for USask include its reliance on the SaskPower electrical grid and aging heating and cooling infrastructure. Work is being done to improve energy efficiency of existing buildings. The presentation emphasized that a sustainability strategy necessitates empowering students with knowledge and skills to identify real-world problems and develop competencies to find future solutions.

New Organizational Senate Member

The University of Saskatchewan Retirees Association was designated to be a new association member of the Senate at the spring meeting.

Independent Auditor's Report

To the Members of Saskatchewan Library Association:

Opinion

I have audited the financial statements of Saskatchewan Library Association (the Entity), which comprise the statement of financial position as at January 31, 2025 and the statement of operations, statement of changes in net assets and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In my opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Entity as at January 31, 2025 and the results of its operations and its cash flows for the year then ended in accordance with Canadian Accounting Standards for Not-for-Profit Organizations.

Basis for Opinion

I conducted my audit in accordance with Canadian generally accepted auditing standards. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian Accounting Standards for Not-for-Profit Organizations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

1. NATURE OF OPERATIONS

The Saskatchewan Library Association (the "Association") is incorporated under The Non-profit Corporations Act of Saskatchewan. It promotes through information exchanges, education and advocacy, a province-wide support of libraries and library services to the citizens of Saskatchewan based on co-operation, accessibility and resource sharing. The Association applied for and received registered charity status in 2003.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

These financial statements are prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASPNO).

Fund Accounting

A portion of the monies received by the Association may only be used for specific purposes and accordingly are accounted for in separate funds. Temporary transfers of monies between these funds are recorded as interfund receivables/payables. Permanent transfers are recorded as transfers in the net asset accounts.

The General Fund accounts for the day-to-day operations of the Association.

The following Restricted Funds do not maintain individual bank accounts, but the accounting records capture the activities and fund balances separately:

Mary Donaldson Award Fund - Initially established as a Trust, with SLA as the Settler on the Deed, to advance the cultural and informational contributions of libraries in Canada, to prepare and disseminate work on library services in the form of an annual lecture and present a Mary Donaldson Award of Merit scholarship. The Trustees transferred the Trust monies to SLA and dissolved the Trust with the approval of the Charities Directorate. The fund continues to support the Mary Donaldson Award of Merit scholarship for a library technician student. The lecture will continue under the auspices of the annual Conference Committee.

Frances Morrison Trust - The Frances Morrison Award is an award of merit for a selected recipient for outstanding service to libraries given in the name of one of Saskatchewan's exceptional librarians, Frances Morrison.

Maureen Woods Education Bursary - The Maureen Woods Education Bursary was established to promote the continued growth of professional librarianship in the Province of Saskatchewan. An annual bursary is awarded to an MLIS student each year.

Continuing Education Grant Fund - The Continuing Education Grant Fund is used to give grants to members to attend workshops, to organize and host workshops, and to attend the SLA conference as first-time attendees.

Indigenous MLIS Bursary Fund - The Indigenous MLIS Bursary Fund is used to support persons of Canadian Indigenous ancestry who are pursuing ALA accredited Master of Library and Information Science graduate programs or equivalents.

Cash and cash equivalents

The Association's policy is to present bank balances and term deposits with a maturity period of three months or less from the date of acquisition under cash and cash equivalents.

Financial instruments policy

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost and tested for impairment at each reporting date. Transaction costs on the acquisition, sale or issue of financial instruments are expensed when incurred. Capital purchases are expensed at the time of purchase.

Financial assets including cash, accounts receivable, long-term and restricted investments are reported at amortized cost.

Financial liabilities including accounts payable and accrued liabilities are measured at amortized cost.

Revenue recognition

Saskatchewan Library Association follows the restricted fund method of accounting for contributions.

Restricted contributions related to general operations are recognized as revenue of the General Fund in the year in which the related expenses are incurred. All other restricted contributions are recognized as revenue of the appropriated restricted fund.

Unrestricted contributions are recognized as revenue of the General Fund in the year received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Grant revenues are allocated to the period the granting agency identifies. Grants relating to a future period are deferred.

Membership revenue is reported as revenue when received.

Programming and exhibition fees are reported in the period the related event takes place or the service is rendered.

Sponsorships relate to specific events and are reported as revenues when the event takes place.

Local businesses contribute services to assist the Association in carrying out its activities. The Association records contributed goods and services received during the year as revenue with an offsetting expenditure. The contributed services are \$NIL (2024 - \$NIL) which are reported at their retail value as provided by the supplier.

Capital assets

Capital assets purchased, such as leasehold improvements, furniture and office equipment are expensed in the year of purchase.

6. FINANCIAL INSTRUMENTS

The Association is exposed to various risks through its financial instruments and management and the board are responsible to monitor, evaluate and manage these risks. The following analysis provides information about the Association's risk exposure and concentration as of January 31, 2025.

Credit Risl

Credit risk arises from the potential that a counter party will fail to perform its obligations. Receivables relate to event sponsorships, government rebates and interest accruals and represent no significant risk of collection.

Liquidity Risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Association has sufficient resources and equity at the yearend to manage its affairs for a reasonable period, so this risk is considered to be low.

Interest Rate Risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. Interest rate risk is considered to be low since the Association has no debt or credit facilities nor does it rely on the interest income to support operations. The restricted funds offer support to their respective programs in relation to equity and investment earnings so some decisions may be affected by unusually low interest/investment revenues.
