Dear members of SUMA,

I am writing to you on behalf of the Saskatchewan Library Association (SLA). SLA's mission is to be the voice of and support to Saskatchewan's library communities. My letter is in regards to the \$3.5 million loss of provincial government funding to seven of Saskatchewan's regional library systems and complete elimination (\$1.3 million) of funding to the municipal library systems in Regina and Saskatoon. (source: http://finance.gov.sk.ca/budget17-18/BG-Education2017-18.pdf) Cutting \$4.8 million from regional and municipal library system budgets represents a miniscule percentage of the province's total operating budget.

SLA is asking for SUMA's support in advocating that the Government of Saskatchewan undertake the following:

- reconsider its budget cuts to regional public libraries
- schedule consultations immediately with regional public library directors and key stakeholders in communities to strategize options for future planning

Part of SLA's advocacy work is encouraging citizens of Saskatchewan to contact their local MLA to raise awareness about how libraries have played a positive role in their life. SLA's statement on March 23 emphasizes that all residents of Saskatchewan must continue to have equal access to a variety of public library programs and resources. (source: <u>http://saskla.ca/saskatchewan-library-association-voices-concern-about-funding-cuts-to-libraries</u>) Saskatchewan was a pioneer in Canada for developing a cost effective province-wide library system and it has operated successfully for many years. <u>http://dx.doi.org/10.21083/partnership.v10i2.3547</u>) However, the Saskatchewan Government's funding cuts to public libraries jeopardizes this model system.

Funding cuts to public libraries are already making an impact. Effective April 4, 2017 electronic borders between Saskatchewan public libraries are closing. (source:

http://www.reginalibrary.ca/blogs/media/blogs/press/BordersclosedbetweenSKlibrarysystems.pdf) The availability, through Interlibrary loan, of books, DVD, audio books, magazines, online resources, and video games to all citizens has ceased. Purchasing new materials will be drastically reduced or cease altogether. Palliser Regional Library system has announced staff layoffs. Libraries will experience severely reduced hours and some will be forced to close

Libraries are also friendship centres, house local history, and display art by local talents. Libraries offer internet access to those who can't afford it and printing services for those in need.

Libraries have a wealth of life-long learning opportunities for people of all ages. Scholarly research has proven that children who have compromised access to quality reading material will experience difficulties later in life. In addition, not having access to a wealth of reliable online resources for people to conduct research and leisure activities from the comfort of their home or in a library will negatively impact the wellbeing of communities.
